Trails Planning Assistance

Trails planning assistance is separate from the Countywide Planning program and occurs through the Cache Regional Trail Coordinator, Carly Lansche. This program is cooperatively funded by a majority of the current CPDO program participants and is housed here with the County. Assistance is available for planning, designing, funding, building regionally significant trail projects and promoting related community events.

Most recently, the Regional Trails Planner has assisted your community with:
